2021 SCCF GRANTS NOW OPEN - AVAILABLE ONLINE - DUE AUG. 31ST

Announcing our 2021 Grant Opportunities, SCCF is excited to offer the same 3 applications as last year to Barber, Comanche, Kingman, Kiowa, Pratt, Rice, and Stafford Counties. SCCF also is excited to introduce a new opportunity to Pratt County Nonprofits. **All grant details are below and application can be found online at www.sccfks.org.**

CHILDREN'S \$5,000 HEALTH GRANT -- This application is available to nonprofits, schools, churches, and cities serving one county in SCCF's service area. This grant is for \$5,000 and must be for a children's health project or program. Children is defined as 18 years or younger. **One recipient will be selected for each of the seven counties SCCF serves.*

COMMUNITY GRANTS -- This application is available to nonprofits, schools, churches, and cities serving one or more counties in our service area. This grant is capped at \$2,000 or less and must be for tangible items.

TEACHER'S \$100 GRANT -- This grant is available to Teachers in our seven county service area for any needed classroom items.

PRATT COUNTY ACHIEVEMENT PLACE - YOUTH DEVELOPMENT GRANT -- SCCF is excited to offer the 1st annual Children/Youth grant funded by the Pratt County Achievement Place Endowed Fund. This grant is available to any nonprofit, school, or church for projects/programs that aims to help children/youth in Pratt County.

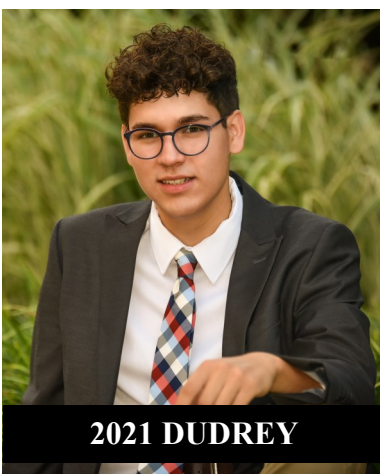

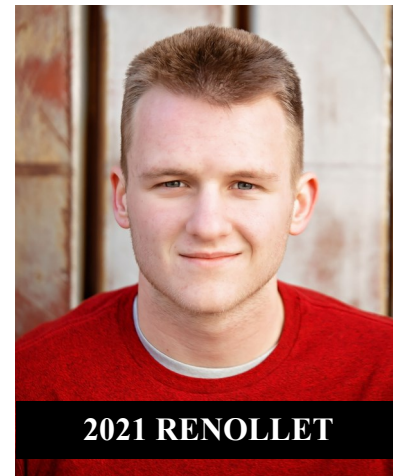

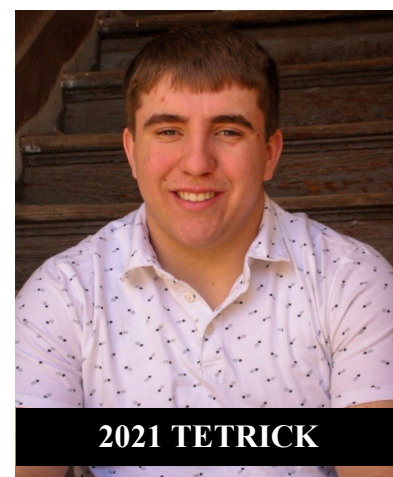

ESTATE PLANNING WITH JOHN GRIFFIN, STEWARDSHIP COUNSELING

Did you know that South Central Community Foundation, along with the Pratt Community College and Pratt Health Foundation, offers free estate planning to our community members and donors? There are many common mistakes in estate planning such as not having an updated plan, no durable powers of attorney / other support documents, or no business / farm transition plan in place that we want to help you avoid.

Why we do this? We believe that everyone having access to estate planning is critical. By offering this community service we allow you to save 10 hours or more of planning time with an attorney.

We contract with John Griffin, an estate planner through Stewardship Counseling, LLC. John, raised in the Netherlands and Northwest Iowa, holds a J.D. from the University of South Dakota School of Law. After practicing law in South Dakota, John joined Stewardship Counseling, LLC in 1991.
